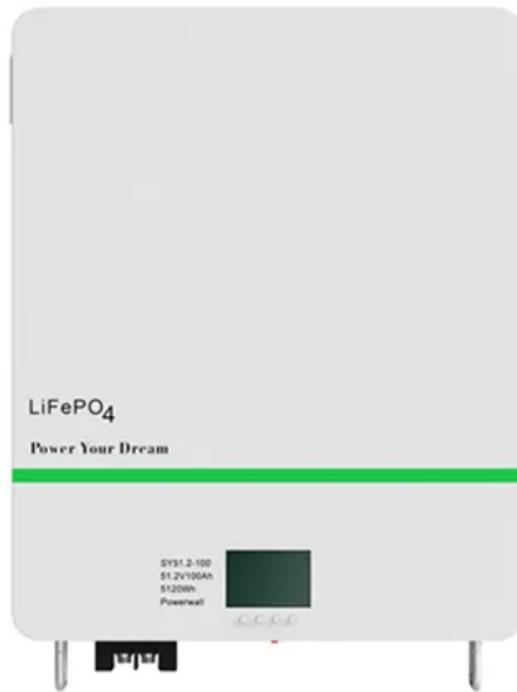

Public participation is essential to the Public Service Commission. The program ensures that participants pay no more than 6% of their annual household.
