Department of Energy Announces \$1M for New Energy Storage Technical Assistance Vouchers. Department of Energy's (DOE) Office of Electricity (OE) today announced a new \$1M storage technical assistance voucher program. NYSERDA offers incentives for grid-connected residential and commercial customers to install standalone energy storage or systems paired with a new or existing on-site renewable generation like solar, fuel cells, or combined heat and power. NYSERDA's Residential and Retail Energy Storage Incentives. On July 4, President Trump signed HR1 (the "One Big Beautiful Bill Act") into law, which accelerates the termination of Residential Clean Energy Credit. Previously scheduled to expire after Decem, the 30% tax credit now ends after Decem. Customers can receive performance incentives for participating in planned events. 
