Many states have either a solar or wind exemption, which provides that equipment used for electricity generation by either solar or wind be exempt from sales tax. Florida, for example, provides an exemption for solar energy systems, and New York provides a specific sales and use tax exemption for. Before the Inflation Reduction Act (IRA) was enacted in 2022, BESS could only access federal tax credit funding when powered by solar and required the business-owned storage to be charged with solar 75 percent of the time. 
