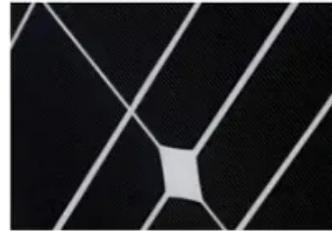
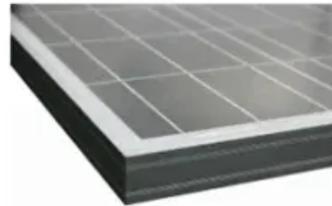

The 2019 Building Energy Efficiency Standards (Energy Code) has solar photovoltaic (PV) system requirements for all newly constructed low-rise residential buildings.
