Installing solar panels is a big investment, but government incentives for solar panels can significantly reduce the cost. The 30% federal solar tax credit, the single biggest financial incentive for homeowners installing solar, will officially end at the end of December. Any system installed after this year won't qualify for the discount that's helped millions of households cut thousands off their installation costs.
