ROOFTOP PHOTOVOLTAIC POWER GENERATION PROJECT AGREEMENT. The principal terms of the Rooftop Photovoltaic Power Generation Project Agreement are set out as follows:

## Solar Power Purchase Agreements

A host customer agrees to have solar panels installed on its property, typically its roof, and signs a long-term contract with the solar services provider to purchase the generated power.


