

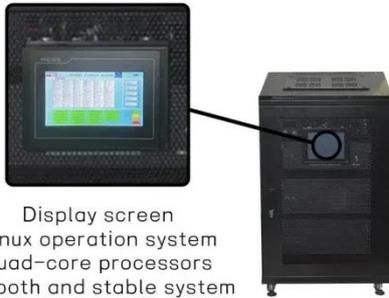

Overview

If construction begins in 2020, 2021, or 2022 the ITC equals 26 percent of eligible costs, and if construction begins in 2023, the ITC equals 22 percent of eligible costs. The amount of the ITC for a qualified solar facility depends on the year in which construction begins. The tax.
