Quick Answer Lithium batteries can be connected in series to increase voltage, in parallel to increase capacity, or in a series-parallel configuration to increase both voltage and capacity. When you need more power, you can construct a battery bank using widely available batteries. For instance, using a common group-size battery such as a group 24, group 27, group 31, or golf cart GC2 group size. Connecting lithium-ion batteries in parallel or in series is not as straightforward as a simple series-parallel connection of circuits. To ensure the safety of both the batteries and the individual handling them, several important factors should be taken into consideration. For the purpose of this blog, all cells are lithium iron phosphate (LiFePO<sub>4</sub>) and 3. Cylindrical cells, inspired by traditional AA batteries, come in various sizes and amp-hours as energy. 


